Upon receipt of an e-mail invitation to submit a secondary application, you will have 30 days from the date of the email to complete the process. If we do not receive your completed secondary application within 30 days we will assume that you want to withdraw your application. If you need more time to complete and submit your secondary application please contact us at medadmit@uci.edu for an extension.

For the secondary application to be considered complete the following components must be submitted:

- 1. Secondary application submitted online
- 2. Letters of recommendation submitted to the AMCAS Letters Service

 Please note that upon receipt of your completed secondary application we will download
 the letters of recommendation on file with AMCAS at that time and these will be the
 letters that will be used throughout the review of your application.
- 3. Secondary application fee
 - A non-refundable fee of \$90
 - To make the payment using your credit card, click on the "Payment" tab on the secondary application
 - The fee is waived for applicants who have been granted a fee waiver by AMCAS
- 4. Permanent residents or approved DACA applicants
 - Applicants who are permanent residents must submit a copy of their green card in order for their application to be considered complete
 - Applicants who have been approved under the DACA program must submit a copy of their DACA approval along with their EAD for their application to be considered complete

 - Please include your AAMC ID number on all correspondence

On the day of your interview you will be notified of any prerequisites that are missing or that we have a question about.

Letters of Recommendation

- UC Irvine participates in the AMCAS Letters Service. All letters of recommendation need to be submitted through this service.
- Upon submission of your secondary application we will assume all your letters of recommendation have been received by AMCAS and the letters on file at this time will be used throughout the review of your application.
- UC Irvine will not accept letters of recommendation sent directly to the medical school.
- Three to six letters are suggested. If you have been involved in research, clinical, or service experience(s), it is recommended that you submit a letter from your PI or supervisor.
- In submitting your secondary application to the UC Irvine School of Medicine you waive all rights to review the content of any letters of recommendation submitted on behalf of your application.
