

645F HIGH RISK OBSTETRICS AT UC IRVINE MEDICAL CENTER

Course Description: The student will work closely with the Perinatal high risk faculty involved in the care of high-risk obstetrics patients. The student will work with some of the Perinatal faculty members in their Private high risk antenatal clinics. The student will round with the Perinatal faculty on all hospitalized high risk patients and will attend antenatal high risk teaching rounds, Monday through Friday. The course will have both labor and delivery activity and night call. The student will spend part of the time in Center for Fetal Evaluation for exposure to antepartum testing and prenatal diagnosis.

Department: Obstetrics & Gynecology

Prerequisites: UC Irvine students must have successfully completed their basic science curriculum and the Ob/Gyn Core Clerkship. Extramural students must be in the final year of undergraduate medical education.

Important: All extramural students must submit a one page **elective application** which will be used during the approval process.

Restrictions: Students that are pursuing an Ob/Gyn residency are accepted for the period September-February. All other students are considered for the period March - August. This rotation is not accepting international students
